Established pursuant to Ordinance #1709 on 6/22/99 – name changed pursuant to Ordinance #1719, adopted by Board 3/28/00 – formerly “Tehama County Children and Families First Commission, established pursuant to Ordinance #1702 on 3/1/99 – Nine members: Board of Supervisors representative; Tehama County Department of Social Services Director; Tehama County Health Agency Director; Superintendent of the Tehama County Department of Education, each for no set term. Five Public at-large members (pursuant to Ordinance #1709 on 6/22/99), from any of the following categories: a) Recipients of project services included in the County strategic plan; b) Educators specializing in early childhood development; c) Local child care resource or referral agency or a local child care coordinating group; d) Local organization for prevention or early intervention for families at risk; e) Community-based organizations that have the goal of promotion nurturing and early childhood development; f) Local school districts; and g) Local medical, pediatric or obstetric associations or societies. Each position is for a three-year term, with the initial terms to be staggered, to expire 1/31/10, 1/31/11 and 1/31/12.
